Dear Prospective Bidder:

Plans and specifications for the above project are now available at the offices of Midwestern Engineers, Inc. Sealed bids must be received by the Owner no later than 6:30 P.M. (Central Time) on May 30, 2024, at the Reo Water, Inc. office, located at 3067 W. State Road 66, Rockport, IN 47635. The bids will be opened at that time. Bids will be received for a single prime contract for each division.

The Division I portion of the project consists of:

- Installation of approximately 32 miles of 3” thru 8” Water Main and Appurtenances. The installation of these mains are broken down into Four (4) Priority Areas. Priority Area 1 contains approximately 10.6 miles of main; Priority Area 2 contains approximately 10.90 miles of main; Priority Area 3 contains approximately 4.2 miles of main; and Priority Area 4 contains approximately 6.4 miles of main. It is the Owners intent to award all priority improvement areas; however, if the costs and budget do not allow all areas to be awarded, only priority areas that can be completed within the project budget will be awarded.

Plans and Specifications are available at the offices of Midwestern Engineers, Inc. located at 802 West Broadway Street, Loogootee, IN 47553. The service charge for Contractors to view the plans and specifications for preparing their bid is as follows: 1) Viewing by download at midwesterneng.com/planroom - \$100.00, per division, and 2) Viewing paper-bound plans and specifications - \$200.00, per division. All service charges for viewing are non-refundable. When specifications are ordered from midwesterneng.com/planroom, instructions for payment will be provided in the downloading process.


